
REGIONAL SCHOOL DISTRICT No. 20 BOARD OF EDUCATION SPECIAL MEETING MINUTES October 30, 2025



1. <u>Call to Order</u> The Board of Education meeting held at Lakeview High School and via teleconference was called to order at 7:06 p.m. by Tiffany Parkhouse.

There was discussion on whether Item 5.4.2 Policy 5122 Assigning Students To a Teacher and Classes in Grades K-12 needed to be removed from the Consent Agenda. This is a first read policy but it was noted this policy was amended. The amended version of this policy will be on the next Board meeting agenda for second read.

There was also discussion about the Out of State Field trip noting a typographical error on the event date being held in March 2025. The field trip is scheduled for March 2026 and all supporting documentation indicating the correct date.

Ashley Westfall made a motion to approve the Consent Agenda, Items 5.1 through 5.4. Margaret Hunt seconded the motion.

Tiffany Parkhouse called for a vote.

The motion passed with Billie Jean Sideris abstaining.

6. Superintendent Update

Dr. Villar shared information about the School Climate Survey, his visits to the district schools, and the PDEC & Advisory Curriculum group.

6.1 Personnel Report

Dr. Villar reviewed the Personnel Report as of October 30, 2025 commenting on vacancies, and new hires of an Educational Assistant and the Financial Coordinator.

7. Public Comment

Individuals offering public comment should please state their first and last name and the town where they reside. Remarks should be limited to no more than three minutes. A maximum time limit of 30 minutes will be allocated for public comment at any one meeting. Individuals representing a common interest or topic may be asked to have one individual speak for the group. Public comments must be relevant to the meeting's agenda. Speakers shall direct all comments to the Board, not to individual BOE members or administrators. Profane or vulgar language, partisan political statements, and comments related to the conduct or performance of staff are not permitted. Public comment is received without Board comment or response, the Board is to keep comments "under advisement." However, BOE members may seek clarification or additional information from speakers through the Chairman.

Dave Wiig, Morris shared his concerns about having Public Comment on the agenda when it is a Special Meeting and gave a suggestion on placement of Public Comment on future meeting agendas.

Becky Hubschmann, Goshen began commenting about the budget. Since the budget is not a topic on the agenda, Ms. Hubschmann will reserve her comments for the next Board of Education meeting.

8. Action Items

8.1.1 <u>Discussion and Possible Action for the Approval of 2026-2027 & 2027-2028 School</u> Calendars

Dr. Villar opened by sharing that there are three versions of each school year calendar. Version 1 is the original presented on October 16, 2025, Versions 2 and 3 reflect feedback from the Board regarding winter break, and school beginning after Labor Day.

Discussion included but was not limited to considering the ASTE sending districts and being good stewards and do our best to align calendars so they do not incur additional transportation costs, ensuring the elementary conference dates align with the trimester end dates, and for calendar year 2027-2028 consider starting school on August 30, 2027 and moving the February professional development date. This will allow for families to have a longer weekend in February for a mini winter vacation should they choose to do so.

Billie Jean Sideris made a motion to approve Version 2 of the 2026-2027 school year calendar as is and Version 3 of the 2027-2028 calendar with moving the start of school up two days and adjusting the tentative last day of school accordingly. Scott Pottbecker seconded the motion.

During discussion Margaret Hunt questioned moving the February Professional Development Day.

Billie Jean Sideris rescinded her original motion.

Billie Jean Sideris made a motion to approve Version 2 of the 2026-2027 school year calendar as is, and Version 3 of the 2027-2028 calendar with the first day of school beginning on August 30, 2027, adjusting the tentative last day of school accordingly, and moving the February 11, 2028 Professional Development Day to February 18, 2028. Margaret Hunt seconded the motion. There was no further discussion. The motion passed unanimously.
