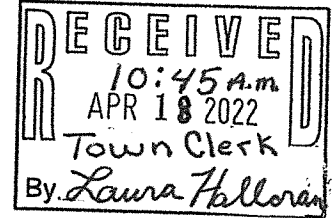

- IV. **Motion** made by Erica Dorsett to accept and award bid for community hall generator to Eagle Electric, LLC in the amount of \$36,788.00. Vinnie Aiello seconded. **Motion carried:** unanimous.
