June 2022

The regular June 9, 2022 meeting was called to order by the chair at 4:00 pm downstairs in the Community Hall. Present were Doreen Gagnon, Connie Trolle, Clif Wheeler, alternate member Robin Viola, and Mike Doyle; Giles Giovinazzi was unable to attend and Robin Viola was appointed to take his position. Also present were Colin Pottbecker and Dennis McMorrow.

On a motion by Connie Trolle, seconded by Clif Wheeler, it was **VOTED** unanimously to add to the agenda the minutes of the special May 17, 2022 meeting.

On a motion by Connie Trolle, seconded by Robin Viola, it was **VOTED** unanimously to add to the agenda Application 22-21.

The meeting minutes of the regular May 12, 2022 and the minutes of the special May 17, 2022 were accepted as written.

Old Business

Application 22-15 from Colin Pottbecker as agent for James McEvoy for lake edge remediation at 108 Bantam lake Road was considered. This site had been visited and the restoration and stabilization of the bank was discussed with Mr. Pottbecker. On a motion by Connie Trolle, seconded by Clif Wheeler, it was **VOTED** unanimously to approve this application for work needed to remove the added material and to stabilize the bank.

Application 22-16 from Colin Pottbecker as agent for Ellen and Rick Plotkin to repair the lake edge boulder wall at 9 Yacht Club Passway was considered. This site had been visited. On a motion by Clif Wheeler, seconded by Connie Trolle, it was **VOTED** unanimously to approve this application for repair to an existing structure.

New Business

Application 22-17 from Kenneth Merz for septic system repair at 13 Harrison Lane was considered. Also submitted was a site plan dated 5-16-22 by Hrica Associates, showing the system above the cottage away from the lake. A previous application for drainage (21-09) was in preparation for this septic system. On a motion by Connie Trolle, seconded by Clif Wheeler, it was **VOTED** unanimously to approve this application for necessary septic repair.

Application 22-18 from the Town of Morris for fire pond dredging at 205 West Street was received. Individual members may visit the site. This will be on next month's agenda.

Application 22-19 from Mitchell Hill for a new home at 8 Westover Lane was received. Also submitted was a site plan dated 6-7-2022 by Berkshire Engineering. Dennis McMorrow explained that zoning limits the size of the home, as well as the amount of impervious surface. He added that they will consider using pervious pavers for the drive. This will be on next month's agenda.

Application 22-20 from Veronica Moran-Lescure for seawall repair at 356 Bantam Lake Road was received. Included was a quote and description of work dated 5-29-22 from DH & K Construction to: fix the right side of the deck and under the concrete deck and fix all the loose stone; the other side as needed 20' from the deck and wall around the patio; fix the blue stone patio pieces that are loose. Individual members may visit the site. This will be on next month's agenda.

Application 22-21 from Scott Demers for a house addition at 58 Palmer Road was received. Also submitted was a architects drawing dated April 2022 by Construction Designs. The addition will enclose an existing outside stairway into the house. The addition will be supported on three piers. Any spoils will be reused or hauled away. On a motion by Clif Wheeler, seconded by Connie Trolle, it was **VOTED** unanimously to approve this application for work in the review area that will have no greater than minimal impact to the lake.

Other Business

One invoice has been received from Attorney Byrne, Invoice #22-06-032j for 1.7 hours, \$297.50. On a motion by Clif Wheeler, seconded by Connie Trolle, it was **VOTED** unanimously to approve payment of this invoice.

The Commission has received three copies of DEEP permit applications for pesticide treatment of ponds in Morris: White Flower Farm (2 ponds); Diedrick pond; Rowe pond.

There was no other business and the meeting was adjourned at 4:45 P.M.
