Reading and Approval of Minutes

Report of the Executive Director

Jim Simoncelli Jr. stated that the Morris Town Assessor came to Eldridge on June 12 to do the Renter Rebate program.

Jim Simoncelli Jr. stated that he mentioned to the RSC the interest the residents had to have the local fire marshal come to Eldridge and talk to the residents about fire safety. A notice will be send out once this is set up.

Jim Simoncelli Jr. stated that he is Chairman of the Salvation Army Service Unit of Litchfield Hills and that if anyone knows of someone who needs emergency assistance to please let him know.

Unfinished Business

- a. Critical Needs Grant (Priority Needs)
 - i. Jim Simoncelli Jr. stated that MHA is in the middle of construction on replacing the bathroom vents and range hoods in the kitchen in all of the units. The next phase of the project that will be completed in the rear access walkway of unit 7 and the replacement of the vents on the roof and the side of the buildings. The window replacement project will be about 3-4 weeks out from starting.
- b. Community Development Block Grant (CDBG)
 - i. Jim Simoncelli Jr. reported that Phase II of the environmental Study on the new land has been completed and the last line of the Chapter VIII, "Interpretation of Site 87-35 and Management Recommendations" reads "No additional archaeological examination of Site 87-35 is recommended prior to Project construction".
