Morris Beach and Recreation





Morris Town Beach

Morris Town Beach Parking Policy Ordinance 2018

- 1. To establish a Morris Town Beach Parking Policy
- 2. Visitors to the Morris Town Beach must obtain a parking pass before permitted to park their vehicles on the Morris Town Beach and Recreational Facilities.
- 3. One-day parking passes are available for Morris residents for a fee \$10.00 per vehicle and for non-residents for a fee \$20.00 per vehicle.
- 4. Season parking passes are available for Morris residents for \$30.00 and for non-residents for \$60.00.
- 5. For this purpose, season is defined as Memorial Day through Labor Day.
- 6. One day parking passes and season parking passes may be purchased from the Morris Town Clerk during regular business hours.
- 7. Gate entry will be monitored and parking passes verified by staff hired by the Morris Beach and Recreation Commission.
- 8. The hours of gate monitoring will be set by the Morris Beach and Recreation Commission and will include, at minimum, weekend day coverage and major holiday coverage.

 Additional hours may be added at the discretion of the Commission.
- 9. Any person violating any of the above rules is subject to a fine of \$50.00.
- 10. All previous recreational facilities rules and regulations apply.
- 11. No trailer parking, no overnight parking and no camping.
