Minutes: Planning and Zoning Meeting 10/7/2020

The October 7, 2020 Town of Morris Planning and Zoning regular meeting was called to order at 7:01 pm by Chairman David Wiig. Commission members present: Veronica Florio, Eileen Narbutas, David Wiig, David Geremia Jr, Douglas Barnes, Bill Ayles, Katie Nack (7:21) and ZEO Jeton (Tony) Adlil.

Eileen Narbutas made a motion to move old business ahead of new business (Town Plan). Seconded by Veronica Florio. Motion carried unanimously.

Old Business:

Town plan was reviewed briefly by the commission. It was determined that a few typos needed to be addressed but other than that it is ready to present at a Town Meeting scheduled for November 9, 2020. Veronica Florio made a motion to present the Town Plan at a public meeting on November 9, 2020 after the typos had been corrected. David Geremia Jr seconded. Motion carried unanimously.

Jocelyn Ayers asked to be added to the 10/21/2020 agenda to address how to get public feedback on the Town Plan and the photo contest.

Veronica Florio made a motion to have the public (town community) determine who wins the photo contest. Bill Ayles seconded. Motion carried unanimously.

Eileen Narbutas will update the photo contest flier to state that the public will decide which photos are selected for the Town Plan and eligible to win gift certificates.

Veronica Florio made a motion to have HVA create a Language Policy Map for \$160 and a digital Zoning Map for \$100 for the Town Plan. Total \$260. Eileen Narbutas seconded. Motion passed unanimously,

New Business:

David Wiig reiterated the letter that was sent to South Farms regarding the Twilight Concert series. He also summarized the response from the South Farms owner, Ben Paletsky.

Eileen Narbutas made a motion to move the approval of minutes to the next regular meeting scheduled for October 13, 2020. Bill Ayles seconded. Motion carried unanimously.

Other Business:

Board membership: Geoff Paletsky expressed interest in joining the Commission. Veronica Florio made a motion to add Geoff Paletsky as an alternate to the Morris Planning and Zoning Commission. Eileen Narbutas seconded. Motion passed unanimously
