My name is Aneta Klusak. I live 2 miles from the venue.

My mother and I moved to Morris last year from Waterbury. We searched for a house for over a year, looking for a place where we could experience quiet. My mother has a number of health issues exacerbated by stress — and the biggest stressor at our former home was the sound of loud vehicles - especially those that blasted their speakers as they drove past the house. We specifically came to Morris to escape this.

What we found in Morris was a tranquil White Memorial preserve and a peaceful community. *This* was a place where we could finally relax and breathe.

What the town is currently allowing to take place at South Farms is unconscionable. The 5 nights of music at 2+ hours per night places MORE auditory disturbance *into my home* than I have ever experienced. This is worse than Waterbury, and I am stunned that I have to make that comparison.

I teach 45 minutes away in Brookfield and get home late, expecting an evening - like ANY working adult - during which I can decompress and prepare my lessons for the next day. I don't get to relax. South Farms has decided that I do NOT get to relax in my own home.

For those that would accuse us of exaggerating or not showing support to a local family during the pandemic, I want to paint this image: imagine that it's your next door neighbor turning their sound system to music of their choice on full volume in their backyard *every single night* for *two hours straight*.

No one else sympathizes because they're distant from this. WE'RE the unlucky ones.

But this would cause outrage anywhere else and it fell on our doorsteps.

When I sit on my deck, the singing and instruments fill my whole yard.

When I sit in my living room with all windows closed, the thumping of the bass often comes through the walls.

You reach a point where the sound triggers a nervous system response. It makes me feel sick.

Our neighborhood's serenity is destroyed. I feel as though I am no longer in a quaint town and by a nature preserve - I feel as though I'm living next to a nightclub, or Yankee Stadium, and that is NOT what I moved here for. I did NOT move next to the Oakdale Theater or the Bethlehem Fairgrounds, where I would have expected to hear this.

This has ruined two months of my life when the pandemic is already crushing my school year at work.

I can't open my window and enjoy fresh air.

I can't be asleep by 9.

I'm getting physically ill because the only reprieve I get from stress in my life now are the Monday nights when there isn't a concert.

The one place we can safely BE during this pandemic is our home, and our properties have essentially been encroached upon by music.

I never consented to this. I can only imagine how people living within 1 mile are suffering.

Any remotely reasonable person would agree that NO business should profit at the expense of even ONE person's suffering, pandemic or not.

But South Farms has been allowed to profit at the cost of my health. And my mother's health. Any attempts the owner has apparently made to mediate this have not reduced the impact on my life. I am greatly suspicious as to why this continues with seemingly no recourse.

At this point, even if the noise is totally remediated, there's an awful taste in our mouths. I have concerns about my home value, taxes, crowds - and how this has completely altered the atmosphere of our small town.

I want to close by saying... the town needs to take responsibility for the turmoil this is causing us.

Once the state of emergency ends, which is February of next year, the zoning permit issued to South Farms will also expire as it was issued pursuant to Executive order 7MM. That order specifically states that the temporary use that is permitted does not become a legal nonconforming use. Thus, municipal estoppel is no longer an issue and a cease and desist order can be issued.

As for the second part of the question, when it can be issued. It can be issued now. The use is not permitted and a violation of the zoning regulations. However, due to our municipal estoppel concerns, the order can state that enforcement is stayed until February 2021, when an inspection will be conducted and a decision whether to pursue further enforcement will be made.

One thing I noticed is that the site plan materials that accompanied the zoning permit application only state that concerts will take place. A Nothing was mentioned about other forms of entertainment, such as comedy shows featuring less than acceptable language.

A final thought: many zoning regulations contain a section on 'Performance Standards' which allows the Commission/ZEO to take action if an approved use is being operated in such a way it creates a nuisance. This would work here.

In light of recent articles that we have read in the Waterbury Republican American, as well as some negative social media attacks against certain town residents, my wife and I feel it is important that we voice our support of the Paletsky's South Farms concert series. We are aware of a small group of residents that have been attacking South Farms for the implementation of a concert venue. Given some of the social media posts I feel attacking is a fair word to use. While understandably there may be some valid minor inconveniences, we are certain that Mr. Paletsky is true to his word that he is working to resolve the concerns. Based on our interactions with Mr. and Mrs. Paletsky over the years it has been very clear that they always have the best interest of their town at heart. My wife and I have been to 3 different shows to date at the new venue, and have been nothing but impressed with the professional manner of the staffing as well as the safety protocols being followed. We find the references in the articles printed in the Republican American regarding issues about Loitering and traffic to be laughable. In our 3 experiences at the venue, we have witnessed staff patrolling the fields to ensure people are not congregating near their cars, as well as staff to ensure all cars are exited smoothly with no back up anywhere to be seen. The most recent article in the paper quoted a person on Isaiah Smith Lane complaining about their life being ruined because of the concerts. We also live on that same street, and in fact live significantly closer to the top of the road than the person in the article. Personally, we both find their claims to be completely outrageous. 
Please find attached videos of different shows recorded from my porch and a map showing where I am. My perception is that the volume has somehow increased. We live in an old house, and I can hear the beat in every room of my home with the windows closed. I can now even hear the crowd cheering, which shows how well the sound travels over the fields between us and the farm even if they are meeting a legal decibel limit. I ask you to please travel the area during a show for the full effect. You \tilde{A} ¢ \hat{a} , \tilde{a} , \hat{c} re welcome to hear it from inside our home. \tilde{A} , \hat{A}

I cannot imagine that anyone in Litchfield County - or the rest of the state? - is suddenly being forced to live with a rock stadium in their backyard without a vote or neighborhood approval. \tilde{A} , \hat{A} My mother has health issues and is distressed by this five nights a week. I teach in Brookfield and come home late, unable to concentrate on lesson planning because of this. The situation simply exceeds the limits of reason. We have sympathy for a business trying to continue under pandemic restrictions, but our chief worry is that this is not a temporary measure. What is the town going to do? Our nerves would be calmed with reassurance that this is not the new normal. \tilde{A} , \hat{A}

My name is Aneta Klusak. I live 2 miles from the venue.

My mother and I moved to Morris last year from Waterbury. We searched for a house for over a year, looking for a place where we could experience quiet. My mother has a number of health issues exacerbated by stress -- and the biggest stressor at our former home was the sound of loud vehicles - especially those that blasted their speakers as they drove past the house. We specifically came to Morris to escape this.

What we found in Morris was a tranquil White Memorial preserve and a peaceful community. *This* was a place where we could finally relax and breathe.

What the town is currently allowing to take place at South Farms is unconscionable. The 5 nights of music at 2+ hours per night places MORE auditory disturbance *into my home* than I have ever experienced. This is worse than Waterbury, and I am stunned that I have to make that comparison.

I teach 45 minutes away in Brookfield and get home late, expecting an evening - like ANY working adult - during which I can decompress and prepare my lessons for the next day. I don't get to relax. South Farms has decided that I do NOT get to relax in my own home.

For those that would accuse us of exaggerating or not showing support to a local family during the pandemic, I want to paint this image: imagine that it's your next door neighbor turning their sound system to music of their choice on full volume in their backyard *every single night* for *two hours straight*.

No one else sympathizes because they're distant from this. WE'RE the unlucky ones.

But this would cause outrage anywhere else and it fell on our doorsteps.

When I sit on my deck, the singing and instruments fill my whole yard.

When I sit in my living room with all windows closed, the thumping of the bass often comes through the walls.

You reach a point where the sound triggers a nervous system response. It makes me feel sick.

Our neighborhood's serenity is destroyed. I feel as though I am no longer in a quaint town and by a nature preserve - I feel as though I'm living next to a nightclub, or Yankee Stadium, and that is NOT what I moved here for. I did NOT move next to the Oakdale Theater or the Bethlehem Fairgrounds, where I would have expected to hear this.

This has ruined two months of my life when the pandemic is already crushing my school year at work.

I can't open my window and enjoy fresh air.

I can't be asleep by 9.

I'm getting physically ill because the only reprieve I get from stress in my life now are the Monday nights when there isn't a concert.

The one place we can safely BE during this pandemic is our home, and our properties have essentially been encroached upon by music.

I never consented to this. I can only imagine how people living within 1 mile are suffering.

Any remotely reasonable person would agree that NO business should profit at the expense of even ONE person's suffering, pandemic or not.

But South Farms *has* been allowed to profit at the cost of my health. And my mother's health. Any attempts the owner has apparently made to mediate this have not reduced the impact on my life. I am greatly suspicious as to why this continues with seemingly no recourse.

At this point, even if the noise is totally remediated, there's an awful taste in our mouths. I have concerns about my home value, taxes, crowds - and how this has completely altered the atmosphere of our small town.

I want to close by saying... the town needs to take responsibility for the turmoil this is causing us.

Hi David,

l'II be unavailable for tonight's meeting. I spoke with Tony this morning during his office hours to specifically respond to the six points in the 9/28 letter. I included some comments below. Please note that none of these issues are in violation of any town ordinances or policies. This operation is in compliance. In mutual interest of working together and dialing in this concept, the concert team is either taking action to respond or have mitigated the concerns on the list.Â

- Volume â€" The production crew has implemented several approaches to directionalize the audio, equalize frequencies to level the balance of audio, and set decibel limiters during the production. Note that we're investigating acoustic fencing solutions options and a few other engineering efforts for further isolation.
- Lighting â€" I reviewed the pictures provided in the packet. Stage lighting is all directed onto my property.Â
- 3. Traffic during regular rush hour (weekdays 4-5pm) vehicles proceeding on Rt 109 West into the 63/109 intersection back up by as much as 14 vehicles. Following the concerts, at this location there never exceeds two vehicles. Â Vehicles exciting the property are held at choke points on the property to eliminate possible congestion.
- 4. Frequency â€" Covid year is an anomaly to the norm. Subsequent years will see a more reasonable balance.
- 5. Comedic content Covid year is an anomaly to the norm. Comedians prefer to perform in indoor clubs.
- 6. Loitering â€" Event security has allowed attendees who arrive early to an event to enter the property and queue on our laneway prior to gate time, so not to impede roadway traffic. Â These appears to address the issue.Â

I noticed there has been a significant influx of letters of support since the last meeting. I hope those statements can be shared with the commission so that there is a fair representation of the community response. Highlighted in the many of the letters, others have clearly stated what benefits this venture has provided our community. Particularly striking, is the note from neighbor John Murray.

I believe that this is a complementary and positive use of the property that provides trickle-down benefits to the local economy. In contrast to some of the other options, I think this the right thing to do. The concert series has provided a unique economic and cultural engine to the area.

Please note the attached document associated with the 2014 permit processed by Scott. Note that the associated uses called out during that process is â€œIndoor/outdoor event rental spaceâ€.Â
