The checking account statement balance is \$97,623.29, earned \$8.09, with no deposits and debits of \$78,773.44 (check #1107 (72,204.28), and check #1108 (100.16)) from November; and check #1109 (6469.00).

The register balance is \$97,548.29 with one long outstanding (#1044 for \$75.00).

The User balance is \$6,031.80 with the interest and \$1,599.27 from the November deposit.

The special assessment account is \$37,371.44 with \$66.98 of the November deposit.

The line maintenance account balance is \$54,175.05 with the debit of \$6469.00.
