INSTRUCTIONS
FOR TOWN
BEACH PARKING PERMIT

2026

We invite you to complete an application for a Town of Morris Beach Parking Permit for 2026 season (May 22 – September 7, 2026). Parking permits are required in order to park at the Morris Town Beach. Each form allows for two different vehicles to receive permits. Should you have more than two vehicles which you plan to park at the Morris Town Beach, you will need to fill out an additional application. All vehicles must be registered to the Morris property taxpayer, or to a tenant of the Morris property taxpayer. If you are renting, you will be asked for a copy of your lease agreement.

To obtain a Town of Morris Beach Parking Permit for the 2026 Season, please submit:

1. Completed application form which can be found herein, on our website, at the Town Clerk's Office or at the Beach and Recreation Office.
2. Copy of the registration certificate issued by the CT State Department of Motor Vehicles for each car you would like a permit for.
3. Signed acknowledgement of your acceptance of the **Morris Town Beach Rules** (Page 2 of the Application).
4. Fee(s), as listed below. Cash or check ONLY made payable to the *Town of Morris*.

SEASON PERMITS

Morris Residents:

\$30.00 per vehicle. Cash or check ONLY, made payable to *Town of Morris*.

Morris residents age 65 or older:

ONE single vehicle is FREE for Morris Senior Citizens! Additional permits are \$15.00 per vehicle, for Seniors. Cash or check ONLY, made payable to *Town of Morris*.

ALL Out of Town residents:

\$60.00 per vehicle. Cash or check ONLY, made payable to *Town of Morris*.

DAY PERMITS

Morris residents: **\$10.00 per vehicle.** Cash or check ONLY, made payable to *Town of Morris*.

Out of Town residents: **\$20.00 per vehicle.** Cash or check ONLY, made payable to *Town of Morris*.

*Day Permits will be collected by the gate attendant upon your arrival to the Morris Town Beach.

MORRIS TOWN BEACH RULES

USE OF THE BEACH:

- All vehicles must have a current Town of Morris Beach Parking Permit affixed to the passenger side windshield.
- Parking permits will be checked by the gate attendant.
- Cars without parking permits will not be allowed to park at the Morris Town Beach. **No exceptions can be made.**

- Clear your picnic area of all items and garbage.
- Please carry out what you carry in.
- Absolutely no campfires are allowed.
- Please do not move picnic tables.

SEASONAL HOURS:

- The beach opens Memorial Day weekend.
- The beach closes after Labor Day weekend.

PARKING:

- Vehicles are allowed in the parking area only.
- No motor vehicles allowed on the beach or in the picnic area.
- ALL vehicles must have and display a current year Town of Morris Beach Parking Permit.

SWIMMING AREA:

- No boating allowed in swimming area.
- No fishing near the swimming area.

SWING SET:

- Children must be supervised at all times.
- Ensure that children play safely.
- Please help us keep our children safe!

LIFEGUARD:

- There is no lifeguard on duty. Swim at your own risk.

OTHER:

- No dogs or pets are allowed on the beach.
- Please curb your dog.
- Only soft (Nerf® or similar) balls are to be used to play catch in the park.
- No alcohol on premises.
- No trailer or overnight parking.
- No camping.

PICNIC AREA:

- Picnic tables are to be shared.
- Tables may not be "staked out" or reserved for an entire day.

Your cooperation in adhering to these rules is needed to maintain a safe, beautiful, and enjoyable beach.

I hereby agree to adhere to the rules stated above, and to ensure that all children in my care will use the beach and swing set in a manner consistent with these rules.
