## 2023 Declaration of Personal Property – CAMPER/TRAILER FORM Barkhamsted, Connecticut

**Filing Requirement** – This declaration must be completed and filed with the Assessor of the town where the personal property is located. Declarations of personal property shall be made annually. Writing "Same as last year" is not acceptable.

**Penalty for late filing** – Failure to file timely will result in a penalty equal to **25%** of the assessment of the personal property. This declaration must be received by the assessor's office or postmarked (as defined in C.G.S. Sec 1-2a) **no later than Wednesday, November 1, 2023.** *Note: Postage Metered Mail without tracking or USPS cancellation must be received in our office by Wednesday, Nov. 1, 2023.* 

**Extension:** The Assessor may grant a filing extension *for good cause* (CGS §12-42). If a request for an extension is needed, you need to contact the Assessor in writing **on or before November 1, 2023** (PA 19-200):

## Wednesday, November 1, 2023

If you no longer own the personal property assessed in your name last year or moved the property out of Barkhamsted, you must also return this declaration to the Assessor and provide information related to the name of the new owner of the property or to where you moved the property (see below). Otherwise, the Assessor must assume that you still own and have failed to declare your taxable personal property.
