- a. Terry Radziewicz: The board reviewed and considered the testimony given along with all information provided and a physical inspection of the vehicle. With a motion made by Robert Brainard, seconded by Frank Kaczynski and a unanimous vote, the board lowered the assessed value of the 2022 Subaru Outback Touring from \$28,870 to \$26,500 using the 2022 J. D. Power Value Guide.
- b. William Muhl: The board reviewed and considered the testimony given along with all information provided and a physical inspection of the vehicle. With a motion made by Steven Blackburn, seconded by Frank Kaczynski and a unanimous vote, the board lowered the assessed value of the 2018 Ram 2500 4x4 Crew Cab ST Tradesman from \$31,240 to \$29,520 using the 2022 J. D. Power Value Guide.
