

1. Meeting was called to order at 7:10 PM at the Town Garage by Chairman Robert Brainard.
2. The Board reviewed and approved minutes from the September 20, 2022 meeting, a motion was made by Frank Kaczynski and seconded by Steven Blackburn to approve the minutes as presented, motion unanimously passed.
3. The Board reviewed the Barkhamsted Assessors Office's Appeal Assessment form for the recent PA 21-2 statute change to allow email submission of forms and documents.
