Superintendent Erica Sacharko shared a shortfall of \$215k Special Ed budget and \$38k shortfall due to ongoing issues with Barkhamsted School Heating and Plumbing systems

First Selectman Meaghan Shared Geneal Government budgets and YTD spending. Of note was Town Counsel line over budget due to ongoing issues with 2 litigations.

Christopher Buck requested a discussion on First Selectman Pay to increase 22%. David Moulton presented data of area towns as supporting data. Discussion from all members was heard.
