

BOARD OF SELECTMEN SPECIAL MEETING MINUTES September 5th, 2025, 8:00 A.M. TOWN HALL

MOTION: First Selectman Nick Lukiwsky presented the year end budget transfers (2024-2025) totaling \$143,071.93 (summary attached to minutes). Motion to accept and forward the transfer request to the Board of Finance made by selectman Mark Mahoney and seconded by Selectman Ray Pech. The motion passed, all in favor.

DISCUSSION: Review of the FY 2025-2026 budget through August 31, 2025. Expenditures are on track.

DISCUSSION: Selectman discussed the Community Center "Events". First Selectman Lukiwsky advised that he spoke with the insurance agent for the town's liability policy. The Town and its organizations are covered under this policy even when alcohol is consumed as long as the alcohol is not being sold. If a non-town organization is using a town owned facility and alcohol is to be consumed, that organization must supply "special event" insurance. Selectmen discussed the need to create a more formal policy for the use of town property.

DISCUSSION: First Selectman Nick Lukiwsky updated the board about the Senior and Community Center HVAC project. C&G completed the upgrade to the system. All appears to be working efficiently.

DISCUSSION: First Selectman Lukiwsky advised that the refinishing of the hardwood floors on the second floor of Town Hall has been scheduled for October 17th. The document scanning is set for the week prior. Scan-Optics will be collecting the documents and scanning at their facility.

Motion: First Selectman Lukiwsky advised that the Barkhamsted Conservation Commission requested the appointment of Joan Noblett. Motion was made by Selectman Ray Pech and Seconded by Selectman Mark Mahoney to make the appointment. The motion passed, all in favor.
