1. NEW APPLICATIONS:

**A. TOWN OF BARKHAMSTED, APPLICANT APPLICATION FOR
RESTORATION OF WEST RIVER ROAD RIVERBANK**

Casey Clapsaddle, Senior Geomorphologist from Princeton Hydro made a presentation via Zoom to the Commission. The need for this riverbank restoration was discovered after a survey of the river in 2016. The restoration will be 580 linear feet on West River Road. The bank will be stabilized with larger stones interconnected with smaller stones and gravel from the river. The construction entrance will be on the East River Road side at 364 East River Road. A fabric will be placed in the river with walls and materials placed on top to hold the equipment. The project will take three weeks and must be completed in June of 2024. Federal and State permits will be pulled for this project. The work will most likely be performed by the Town road crew. Martha Sullivan made a motion to accept the application as regulated, significant and set for a public hearing on

September 12th, seconded by Ian Osborn and unanimously approved. The commission asked that someone from the Town road crew be present at the public hearing.
