1. INLAND/WETLANDS ENFORCEMENT OFFICER'S REPORT:

Inland Wetlands Officer Brydon advised the commission of an Agent Determination

that was approved for an emergency septic repair at 24 Eddy Road due the fields

leaking into a nearby stream. The repair was designed by tom Grimaldi with R.R.

Hiltabrand.

3. PUBLIC HEARINGS:

A. MALLORY BROOK PLAZA, LLC., OWNER CALCO CONSTRUCTION & DEVELOPMENT, INC. APPLICATION FOR CONSTRUCTION OF NEW TRACTOR SUPPLY RETAIL STORE

Sara Costagliola, Senior Engineer from BL Companies, was present and showed site plans for the new Tractor Supply Retail Store. Two hydro-dynamic separators have been installed. Simon suggested another separator be added to the right side of the property. This will be taken into consideration. A trailer was added to the right side of the property to pick up large items. The stockpile was relocated to the rear of the site.

Linda Ganem asked a question about the wildlife, specifically the beavers, and was assured that no harm would be done to the wildlife on the premises.

The proposed time frame to submit to PZC is next week. The project could take 6-7 months. Motion to close the public hearing made by Tooker, seconded by Maher and unanimously approved.

Motion made to approve the application, as presented, with the following conditions made by Sullivan, seconded by Tooker and unanimously approved.

- 1. Permanent markers shall be placed at 100- and 200-foot intervals along the surveyed wetland boundaries.
- 2. Activity should follow the 2002 Sedimentation and Erosion Control Guidelines. All sedimentation and erosion control measures shall remain in place and be maintained until a permanent vegetative cover is established.
- 3. Inland Wetlands Enforcement Officer to be notified in writing one week prior to construction.
- 4. Any excess materials will be removed from site; (i.e. no stockpiling). No stumps shall be buried on-site.
- 5. If individual site plans differ in any way from the approved plan, the individual site plan must be resubmitted to the Wetlands Commission.
- 6. All vehicles working on site should be equipped with spill kits.
