Barkhamsted Recreation Commission Special Meeting Minutes November 8, 2021

- The meeting was called to order at 6:28 PM. Commission members Peter Bakker Jr., Megan Nelson, Melissa Roy, Jon Sweeton and director Donna Carney-Bastrzycki were in attendance. Nora Bishop and Pam Wells were absent.
- There was no public input.

Correspondence:

Halloween Sock Hop, Ski Club (correspondence with school), Holiday Lights and Christmas in Riverton.

Old Business:

Halloween Sock Hop:

- The Halloween sock hop was a success. There was positive feedback from students, parents and volunteers. There was a great quality of prizes and the treat bags were a big hit.
- There was a small hiccup/scheduling conflict with the DJ, however, the owner of the business was able to send a replacement. He did a great job - interacted well with the kids and played a good mix of music.
- 152 participants signed up but with parents and volunteers we probably had around 170 (record year was 2019 with 198 participants).
- It was mentioned that the location at peoples forest pavilion is a great set up. Next year we will try and get more lighting however it worked well with what we had (lights, flashlights and borders in place).
- Total profit was \$176.99

Pre-Thanksgiving Hike:

- Currently there are 8 people registered but we are expecting more.
- · Commission members are being asked to help spread the word.
- The plan is to go up to the boardwalk which is about a 3.5 mile hike. We will have snacks at the end of the hike location will be dependent on the weather.

Ski Club:

- We currently have 11 registered. We feel that is a good number with Covid and we meet the minimum bus requirements.
- Starts January 5th and lasts 5 weeks (snow dates may push out the date). Volunteers are still needed. Ideally we need 5 to 6 chaperones. Currently have 1, Jennifer Grant.
- The check to sundown will be mailed November 9th as the deadline is Friday, November
 Will circle back in December's meeting.

New Business:

Holiday light Contest:

- Last year this event brought a lot of fun and excitement to the community when many had to stay home due to travel restrictions and strict covid protocols.
- It would be great if this event would continue. However, the commission already has 2
 events that require a lot of work and time: Christmas in Riverton (holiday crafts) and

 event since breakfast with Santa is not scheduled again this year. Peter offered to bring
 this idea to them.
- If the women's club is unable to to take the holiday lights on, we have a "plan b" to keep the mission of last year event: "Shine Bright Barkhamsted". This would be a virtual contest where anyone who wants to enter can post a picture in the town Barkhamsted page. The picture with the most likes will win a "cover picture" on the Barkhamsted's town page. Address can be added to the submitted picture if the contestant would like (optional).
- Peter will circle back with feedback from the womens club and that will determine what route we go.
