Electors and others qualified to vote at are hereby warned of a Town Meeting for the Town of Canaan, CT to be held at the Falls Village Emergency Services Center located at 188 Rt. 7 South, Falls Village, CT on Friday, June 06, 2025 at 6:30 PM to act on the following:

1. Shall the Town of Canaan appropriate up to the sum of \$2,422,826.00 for general municipal purposes for Fiscal Year 2025 - 2026?
2. Shall the Town of Canaan appropriate up to the sum of \$2,390,265.00 for educational expenses for the Lee H. Kellogg School for Fiscal Year 2025 - 2026?  
  
*(Region One expenses for the Town of Canaan are \$1,543,685.00 which has been approved by referendum bringing the total education expense to \$3,933,950.00)*
3. Shall the Town of Canaan appoint the following as official Depositories of the Town of Canaan: National Iron Bank, Salisbury; NBT Bank, Salisbury and North Canaan; Torrington Savings Bank, Falls Village and Northwest Community Bank, Salisbury for Fiscal Year 2025 - 2026?
4. Shall the Town of Canaan consider and act upon rescinding *An Ordinance Concerning Trailers, Trailer Camps or Trailer Parks and Mobile Home Parks* as the Planning and Zoning Commission adopted regulations regarding *Trailers*?
5. Shall the Town of Canaan consider and act upon a reimbursement made to the Town's Fire Commission from the Aquarion Water Company as a result of overpayments in the amount of \$26,427.31 and utilize said amount as an addition to the Ambulance Reserve (1028 - Non-Recurring Capital Accounts #1702838046)?
6. Any other business to properly come before this meeting

Procedure for the proceedings: Roberts Rules of Order will prevail where not in conflict with Parliamentary Law. In accordance with the principles of deliberative meeting under both Roberts Rules and Parliamentary Law participation will be reserved to those present.
