AN ORDINANCE CONCERNING DUTIES, HOURS, SALARY, HEALTH AND RETIREMENT BENEFITS OF THE TOWN CLERK

BE IT ORDAINED by the Assembly of the Town Meeting that the following statements will describe the position of Town Clerk in the Town of Canaan (Falls Village), Connecticut.

1. The Town Clerk shall have duties as specified by the Connecticut General Statutes, Section 7, Chapter 92.
2. The Town Clerk shall have the following minimum office hours: Monday, Tuesday, Wednesday and Thursday from 9:00 AM to 3:00 PM
3. The Town Clerk shall receive an annual salary to be recommended by the Board of Selectmen to the Board of Finance who shall determine such salary amount and make it a part of its recommendation of the annual spending plan to be approved at Town Meeting. Should the Town Clerk possess a Town Clerk certification, a stipend for such certification will be an additional benefit. These payments will be in lieu of any and all fees.
4. The Town Clerk shall be the principal point of contact for those members of the general public seeking information and legitimate business with the Town as per the policies of the Board of Selectmen.
5. The Town Clerk shall have such health and retirement benefits, if any, as are deemed appropriate as may be established by the Board of Selectmen.

Town of Canaan Hybrid Green Burial Rules and Regulations

Hybrid green burials are natural burials that take place throughout the conventional section of the cemetery.

- Bodies may not be embalmed by any non-biodegradable chemicals. Synthetic implants, including dental fillings, joints, and pacemakers are allowed.
- Clothing must be made from 100% biodegradable material such as cotton, wool or linen. No jewelry, photographs, or other items unless biodegradable and approved by the sexton.
- Caskets and shrouds must be 100% biodegradable. No paint, varnish, synthetic materials, nails or inorganic glues.
- Wooden caskets must be made of North American wood from non-endangered tree species. Imported woods are not permitted. Biodegradable cardboard is acceptable.
- Burials cannot be any deeper than 4 ½ feet (3 ½ feet is optimal).
- No vaults or grave liners.
- Gravestones are allowed with sexton approval.

The Town of Canaan Green Burial Rules and Regulations are designed to reduce the environmental impact of interment. Any questions or concerns should be directed to the sexton.

Note: Hybrid Green Burial Rules and Regulations are subject to change.
