

Falls Village Recreation Commission
Regular Meeting Minutes
Wednesday, July 13th, 2022 at 7:00 PM

A meeting of the Falls Village Recreation Commission was held in person on this date and called to order at 7:06 pm by Dan Carr. In attendance: Director Emily Peterson, Waterfront Supervisor Carla Galaise, Co-chairmen: Dan Carr and John Morrissey, Commissioners: Daipai Horace, Melissa Lopes, Ted Moy, and Thomas Wilson. Old Business:

1. **FVRC Meeting Minutes of June 8th, 2022:** MOTION by Dan Carr, seconded by John Morrissey, to approve the Meeting Minutes of June 8th, 2022, as submitted. Motion passed unanimously.

New Business:

1. **2022 Pool Season Update from Waterfront Supervisor:** Carla ran an in person orientation with all new and returning lifeguards at the start of the pool season. Lifeguards have been sent emails regarding reminders of scheduling policies and procedures (as the policies have been updated since the 2021 season). Since opening the pool to non-residents, day and season passes are being sold and ice cream sales are going well. Money is coming in and Carla has updated income sheets for the lifeguards to record incoming cash. Carla reported that the pool bottom is rough and many patrons are cutting their feet on the bottom of the pool. Signs have been posted about the issue and people and many are wearing socks of watershoes. Also reported, more than half of the lounge- chairs need to be repaired or replaced. CKC has started. There is an increase of food outside the pool area which is messy and there is an increase in the ants. Counselors have been reminded that they have to make sure that the areas used are clean at the end of each day. Carla is working on weeding the playground area. As of this meeting, there are enough lifeguards able to work at the pool until the end of August. Discussion followed.

2. **Summer Events: Family pool party, movie night and/or s'mores night at the pool.** Discussion regarding possible events to be held at the pool during the remaining July and August. Pizza & S'mores will be outside of the pool at 3 PM on the last day of CKC July 29th for those that attended any of the 3 weeks of CKC. Adult only movie night in the works to be held on August 5th (raindate) August 6th (Jaws to be played).

3. **Other Business:** Emily Peterson reported that she had been contacted by a member of the BOE - Kellogg and the FVCT BOD regarding an after-school program. The are still in the information gathering stage. Emily Peterson will report their findings to the FVRC.

4. **Adjournment:** With no further business to discuss, the meeting adjourned at 8:00 pm.
