Old Business:

1. **2022 Pool Season:**

- A. **Update from Waterfront Supervisor:** Report from Carla Galaise (waterfront supervisor) was received by Emily Peterson (Director) and read to commissioners.
- B. **Update from Professional Cleaning Service and The Town Crew:** Pool is scheduled to be open on Monday, June 20th, 2022. The pool house was opened and cleaning has been started and cleaning supplies have been ordered. The pool has been uncovered and cleaning process has started.
- C. **Pool Clean Up Day (June 11, 2022 at 10AM):** Pool Clean Up and set up day is scheduled for June 11th at 10am. Clean up of office area, bathrooms, guest chairs, playground and other necessary tasks, including setting up second shade, liguard chairs, and picnic area.

2. **Event: Block Party Jun 18, 2022 (Noon -3:00):** Commission discussed final details for summer kickoff block party to be held on June 18th downtown between the 12pm and 3 pm. Information about the event has been posted on social media and the town website. Set up will begin at 10am.

3. **Pool Enhancements from remaining balance of Fundraiser (\$3,252):** Commission discussed use of the remaining balance. Suggestion was made by Emily Peterson to use some of the money to plant a pollinator garden at the recreation center, commission supports this idea. Emily will discuss this with Falls Village Community Development Corporation (FV CDC).

4. **Pool House Repairs and Maintenance- Staining the pool house, window and door repair and cupolas:** Commissioners will make sure that the pool house windows and doors are secured. Emily Peterson will followup on the current status of the cupolas.
