PURSUANT TO SECTION 9-185 OF THE CONNECTICUT GENERAL STATUTES REGARDING THE ORDINANCE POWERS GRANTED TO A MUNICIPALITY; it is hereby enacted by the Town of Canaan.

Pursuant to Section 9-185 of the Connecticut General Statutes, the Town Treasurer shall be appointed by the Board of Selectmen. The term of office shall be four years. The first term shall begin the first Monday of January, 2024, except that, should a vacancy occur in the elected Town Treasurer position, the Selectmen shall appoint a Town Treasurer to fill the balance of that term. The Board of Selectmen shall determine the terms and conditions of employment and proposed compensation annually to the Board of Finance.

The ordinance shall become effective fifteen (15) days after publication of this notice. It is available at the Town Clerk's office for inspection.

Legal Notice Town of Canaan (Falls Village)

At a Town Meeting held on June 01, 2024, the Electors and others qualified to vote at Town Meeting enacted the following ordinances:

AN ORDINANCE REGARDING ALLOWING DOGS ON PROPERTY OTHER THAN OWNER'S

- 1. No owner or keeper of any dog shall allow such dog to be upon the property of another unless:
- a. The owner of the land has given the owner or keeper permission to have the dog so present;
- b. On public, quasi public or off the property of the owner or keeper, the dog is properly on a leash of no more than ten (10) feet in length securely held by the owner or keeper of the dog.
- 2. Owners and keepers of dogs shall be responsible for the immediate removal of any feces discharged by said dog when such discharge occurs off the owner's or keeper's property, this includes but is not limited to sidewalks, public street, median dividers within public streets, grass or paved strips between streets and sidewalks, public parks and other public property;
- a. This provision of the ordinance shall not apply to any visually impaired person by a guide dog or any physically handicapped person who under the circumstances are unable to comply with this ordinance.
- 3. Any violation of this ordinance shall be punishable by a fine of no more than twenty five dollars (\$25) for the first offense and fifty dollars (\$50) for the second offense.
- 4. This Ordinance shall be enforced by the Town of Canaan Animal Control Officer.

AN ORDINANCE REGARDING BAZAARS, RAFFLES AND BINGO

Section 1: Authorization

The Town of Canaan hereby adopts the provisions of Connecticut General Statutes, Section 7-169 to 7- 186, inclusive, as amended by Public Act No 17-231, effective January 1, 2018. Terms as defined in the Connecticut General Statutes, as amended by the Public Act, are hereby incorporated by reference.

Section 2: Bingo Games, Bazaars and Raffles

The Town of Canaan hereby confirms its prior authorization of bingo games, bazaars and raffles within the municipality, subject to the provisions of the Connecticut General Statutes, as amended by Public Act No. 17-231

Section 3: Application Forms, Permit Fees

The Town of Canaan hereby authorizes the use of the application forms modeled upon those forms previously used by the Commissioner or Consumer Protection and adopts the maximum permit fees authorized by the Connecticut General Statutes, as amended by Public Act No 17-231, and as may subsequently be amended by future legislation.

Section 4: Administration

The First Selectman, the Chief Executive Officer of the Town of Canaan, is hereby authorized to administer the provisions of the Connecticut General Statutes applicable to bingo games, bazaars and raffles previously administered by the Commissioner of Consumer Protection and now delegated to the municipality pursuant to Public Act No 17-231, effective January 1, 2018.

This Ordinance shall become effective fifteen (15) days after publication in a newspaper having circulation in the Town of Canaan.
