2. Set Fiscal year 2026-2027 Mil Rate

- a. Budget passed on June 18th with an additional \$248,000 cut. Durham's share of the RSD13 budget is \$27,707,079. Educational cost sharing is \$3,293,232 for a net RSD13 budget of \$24,413,847. Total to be raised by taxes is \$29,649,191. Mil rate calculated to be 27.72. Tax Collector Martin French recommend setting the rate at 28 mils to account for past due taxes that are now fully collected
