8. Discuss and take action to enter into an agreement with SNE Building Systems for expansion of the Building Maintenance System to the Community Center

Charles Bedo, Facilities Manager recommended moving the Building Maintenance System at the Community Center over to the Towns current vendor SNE Building Systems replacing Sieman's. This change will result in energy efficiency and overall cost of the system will reduce the yearly support agreement by approximately \$12,000 a year. The Town Hall and Library are currently with SNE Building Systems, and this will allow for continuity with all buildings being under one vendor.

First Selectman Rea noted that he met with the Middletown Police Chief and several vendors. He stated that Middletown already had an ordinance in place prior to the placement of automated traffic enforcement safety devices and have since that time updated their ordinance based on what they learned during the implementation of the devices. First Selectman Rea noted that he will be sending the Town of Durham draft ordinance along with Middletown's updated ordinance to Town Council for further review. This item will be put on the next agenda for further review and possible action to set a public hearing.

Beth Moncata, Finance Director advised the Selectmen the Town became a beneficiary of a trust under the Will of John Spencer Camp that provided funds to be used for providing education and education facilities in 2003. The fund has not been utilized since this time. She suggested the Board of Selectmen, in conjunction with the incoming Treasurer, discuss the potential of using these funds for a yearly scholarship to local students. All Selectmen agreed. Selectmen Chadd noted the Durham Fire Company has set up a scholarship and would share their details regarding how it was set up.
