BOARD OF SELECTMEN'S MEETING JANUARY 9, 1981

The Board of Selectmen's Meeting of January 9, 1981, was called to order at 7:50 p.m. Members present were M. Foster Mather First Selectman, Maryann P. Boord and Gregory G. Curtis. Townspeople present: William Moore, Ona McLaughlin, Linda Dean, Joseph Carney and members of the Library Site Selection Committee.

Motion by M. Boord, seconded by G. Curtis to approve minutes of the December 18, 1980, meeting: a unanimous vote.

Mrs. Leo Willet presented the report of results of the committees public opinion survey (copy attached). The committee asked that the Board of Selectmen consider the results of the survey and report back to the committee before February 12, 1981 with continued directives.

Joseph Carney discussed with the Board of Selectmen some of the aspects of Regional District #13 sale of Center School (Middlefield) and Brewster School (Durham). No action was taken.

G. Curtis moved that the Board of Selectmen postpone action on the request for a street light by Mrs. Offinaski's at the corner of Partridge Lane and Edwards Road until budget time when it can be considered along with other requests. The motion was seconded by M. Boord and passed unanimously.

M. Boord moved that the Board of Selectmen recommend to keep Robert Frank, Building Inspector, on a contractual retainer basis rather than include in payroll service. The motion was seconded by G. Curtis and passed unanimously.

G. Curtis moved that the Board of Selectmen request approximately \$1,300 from the Board of Finance for purposes of purchasing a new typewriter for the Selectmen's office. The exact sum will be determined by actual bids if and when provisional approval is granted and passed unanimously.

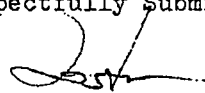
