

**Durham Ethics Commission  
Regular Meeting Minutes  
Durham Town Hall – Third Floor  
November 25, 2025**

- 1. Call to Order** – Chairman James Talbert-Slagle called the meeting to order at 7:00 p.m. on Tuesday, November 25. Present: James Talbert-Slagle, Nikki Maletta, Kurt Peterson, Brian Dreyfus, and Lynne Allen. .
