- F. DeFelice stated that the same members were seated and confirmed that the legal notices and signs had been posted. Photographs verifying the posted sign were provided. The legal notice was then read into the record.
- B. Rea, First Selectman, explained that the owner of the Hard Hat Tavern, located at 100 New Haven Road, is seeking to create additional parking. He provided background on the restaurant's ongoing parking challenges. The owners have offered to fund the parking improvements and agreed that, should any issues arise, the area would revert to a noparking zone. Nathan Jacobson and Associates, the Town Engineer, supplied plans and mapping of the site. The proposal includes adding seven parallel parking spaces along Birch Mill Road. The area will remain unpaved, with processed gravel to be used as the surface.

The wetlands area was identified and discussed in relation to the proposed work. It was noted that the new parking spaces are intended for restaurant employees. Members discussed how to clearly inform the public that the area is designated for parallel parking only, as well as what types of signage would most effectively serve drivers, pedestrians, and overall safety.

A motion was made by P. Augur, seconded by M. Laudano, to exit the public hearing and resume the regular meeting. All ayes. Motion passed.
