Old Business: None

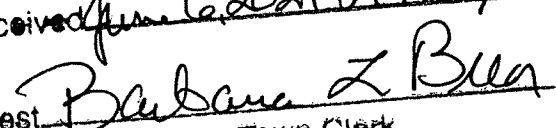
New Business: RFP/Bid was discussed for the air conditioning for the drill hall, commission clerk to start the process since the item was approved for 2024-2025 fiscal year.
