New Business:

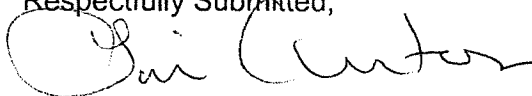
- A. Capital was briefly reviewed and everyone was asked to come back next month with suggestions.

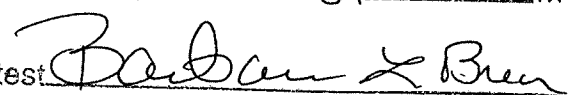
***IN A MOTION** by Mike Bergin and seconded by Don Sage it was **VOTED** to adjourn the meeting at 7:38pm.*

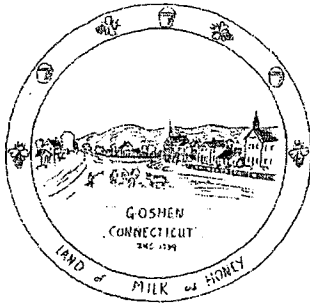
