Dive class is going well. Chief Hall wanted it on the record that the Fire Company paid for the cost of the Dive Class. Will have an EMT course coming up, with Hartford Health Care teaching. Ambulance 9 should be here within a month. Ambulance 8 and Dive rig have new tires. No replacement for janitor at this time and still searching. Dan Lucas has been doing maintenance and some cleaning. Pump testing in the next 30 days. Hose testing is later in the year. Bill Gelormino made note that they will be having a survey done for the new building for storage at the firehouse (est was for \$2,000).

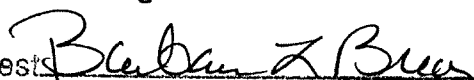
