1. **Call to order:** Todd M. Carusillo called the meeting to order at 5:02 p.m.
2. **Approval of the minutes of the Special Meeting of Monday, November 3, 2025:** A **motion** was made by Selectman, Dexter S. Kinsella, seconded by Selectman, Scott Olson to approve the **Special Meeting minutes of November 3, 2025** as submitted. Voted unanimous.
3. **Approval of the Payroll and Warrant – November 13, 2025:**
In a **motion** made by Selectman Scott Olson, seconded by Selectman Dexter S. Kinsella, it was voted to approve the Payroll and Warrant dated 11/13/2025 in the amount of \$89,505.02. The Warrant was in the amount of \$62,918.56 and the Payroll was in the amount of \$26,586.46. Voted unanimous. Included in the Warrant were: *Down to Earth* - \$14,800; Mountain Top Trucking - \$13,923.16; Nationwide - \$5,662.11; Sherwin Williams - \$5,969.95.
4. **First Selectman's Report:**
First Selectman Todd Carusillo publicly offered sincere "Congratulations" to the newly elected First Selectman for the Town of Goshen, Seth Breakell. In addition, Mr. Carusillo expressed his gratitude to everyone for their support and the best of luck going forward. Selectman Dexter S. Kinsella expressed his wishes of good luck to Todd Carusillo. Selectman Scott Olson stated "first selectman" is a demanding task and wished Todd Carusillo good luck. He highlighted some of the "to do" items for the new Selectman – attorneys, the MOU, pensions, etc. In addition, Mr. Breakell will need to review the current status of the Code of Ethics Committee and the Code of Conduct Committee. In a **motion** made by Selectman Dexter S. Kinsella, seconded by Selectman Scott Olson the two aforementioned Committees (Ethics, Conduct) are asked to table "approval" until Seth Breakell – First Selectman nominee – has an opportunity to review content therein. Motion passed.
