8. NEW BUSINESS:

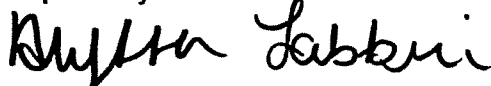

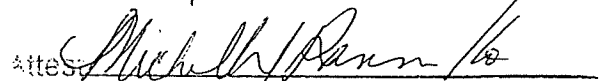
