1. CALL MEETING TO ORDER: Seth Breakell called the meeting to order at 5:00pm.

2. APPROVAL OF MINUTES : The minutes of April 14, 2026 regular meeting were reviewed and approved as written. **Motion** by Dexter Kinsella and seconded by Scott Olson it was **voted** to approve the regular meeting minutes from April 14, 2026 as written. Motion carries.

3. APPROVAL OF THE PAYROLL AND WARRANT - April 23, 2026: **Motion** by Scott Olson and seconded by Dexter Kinsella, it was **voted** to approve the Payroll and Warrant dated April 23, 2026 in the amount of \$74,754.22. The Warrant was in the amount of \$46,826.42 and Payroll was in the amount of \$27,927.80. Included in the Warrant were: Cardinal Engineering: \$1,800; CIRMA (liability and workers comp insurance): \$17,582; Logan Steel: \$6,000; Morton Salt: \$12,271.78. Motion carries.

4. FIRST SELECTMAN'S REPORT: First Selectman Seth Breakell clarified the Morton Salt invoice, explaining that discounts were applied due to delivery delays and are reflected in the current bill. He also confirmed that he has contacted Connecticut State Police Troop B twice to request targeted enforcement on Town roads. Additionally, he met with Region 20 Selectmen to discuss the Region 20 audit, and they are scheduled to meet with State legislators tomorrow to advocate for the State to assume the associated costs rather than the Towns.

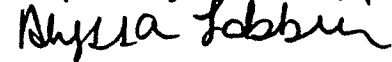

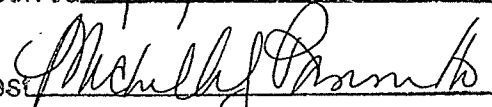
