Present: Seth Breakell, Dexter Kinsella, and Scott Olson.

1. CALL MEETING TO ORDER: Seth Breakell called the meeting to order at 5:00pm.

2. APPROVAL OF MINUTES : The minutes of March 17, 2026 regular meeting were reviewed and approved as written. **Motion** by Dexter Kinsella and seconded by Scott Olson it was **voted** to approve the regular meeting minutes from March 17, 2026 as written. Motion carries.

3. APPROVAL OF THE PAYROLL AND WARRANT - March 26, 2026:

Motion by Scott Olson and seconded by Dexter Kinsella, it was **voted** to approve the Payroll and Warrant dated March 26, 2026 in the amount of \$74,741.21. The Warrant was in the amount of \$47,467.40 and Payroll was in the amount of \$27,273.81. Included in the Warrant were: Anthem Blue Cross Blue Shield: \$23,979.52; Cargill Salt: \$11,036.78; Dime Oil: \$2,774.40; Sterling Metals: \$1,266.00. Motion carries.

4. FIRST SELECTMAN'S REPORT: First Selectman Seth Breakell noted that "First Selectman- Town of Goshen, CT" Facebook page is updated and will be used to update residents on events, announcements and information. He encourages residents to follow along.

5. BUDGET REVIEW: Quick review was done on the following budgets: Cemeteries (budget decreased by \$1,159.69 due to Trusts.) Elections (increased by \$6,182 due to early voting requirement changes.) Building Official (increased by \$15,673 due to under budgeting from previous year budget. Increase reflects percentage of permit fee compensation.)

Motion by Dexter Kinsella and seconded by Scott Olson, it was **voted** to receive and forward the 2026-2027 budget to Board of Finance. Motion carries.

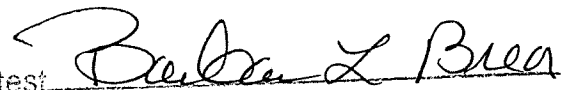
