1. CALL MEETING TO ORDER: Seth Breakell called the meeting to order at 5:00pm.

2. APPROVAL OF MINUTES : The minutes of June 2, 2026 regular meeting were reviewed and approved as written. **Motion** by Dexter Kinsella and seconded by Scott Olson it was **voted** to approve the regular meeting minutes from June 2, 2026 as written. Motion carries.

3. APPROVAL OF THE PAYROLL AND WARRANT - June 11, 2026: **Motion** by Scott Olson and seconded by Dexter Kinsella, it was **voted** to approve the Payroll and Warrant dated June 11, 2026 in the amount of \$82,834.96. The Warrant was in the amount of \$50,303.32 and Payroll was in the amount of \$32,531.64. Included in the Warrant were: Brigham Industries: \$2,559; Fire Equipment Headquarters: \$4,328.33; Nationwide Financial: \$4,840; Pine Valley Materials: \$7,808.40; Target Enterprises: \$7,521.
