1. CALL MEETING TO ORDER: Seth Breakell called the meeting to order at 5:00pm.

Motion by Dexter Kinsella and seconded by Scott Olson it was **voted** to move new business item **7a. A Pavement Management Report from Haley Ward** to the top of the agenda. Motion carries.

2. APPROVAL OF MINUTES : The minutes of July 14, 2026 regular meeting were reviewed and approved as written. **Motion** by Dexter Kinsella and seconded by Scott Olson it was **voted** to approve the regular meeting minutes from July 14, 2026 as written. Motion carries.

3. The Town sold two cemetery plots on West Side Road this week. Chip Sealing project has been completed but came in over budget due to increase on asphalt adjustments. Requests to use \$54,000 from TAR funds.
