Regional School District No. 6 Pension Plan & Election of a Trustee

Town of Goshen, Connecticut
SPECIAL TOWN MEETING
February 10, 2026

Ordinance Co-Sponsoring the Former Regional School District No. 6 Pension Plan and to Elect a Member of the Intermunicipal Board of Trustees for Said Plan

Section 1. Authority

This ordinance is adopted pursuant to General Statutes §§ 7-339a through 7-339l and 7-450.

Whereas certain staff of said former school district participated in the former Regional School District No. 6, Retirement Plan (the “Plan”); and

Whereas the former Regional School District No. 6 has ceased operation, leaving behind the Plan.

Now therefore, the Town of Goshen, in cooperation with the Towns of Morris and Warren, adopts this ordinance to assume co-sponsorship and to help administer the former Regional School District No. 6 Retirement Plan to comply with the applicable state and federal laws and regulations.

Section 2. Amendment of Goshen Code of Ordinances

The Goshen Code of Ordinances, Title 50, “Pension & Retirement System”, is hereby amended by adding new § 50D, “Intermunicipal Board of Trustees for the Former Regional School District No. 6 Pension Plan”:

“§ 50D INTERMUNICIPAL BOARD OF TRUSTEES FOR THE FORMER REGIONAL SCHOOL DISTRICT NO. 6 PENSION PLAN

(A) Pursuant to §§ 7-339a through 339l and 7-450 of the General Statutes, the Town of Goshen hereby assumes co-sponsorship of the former Regional School District No. 6, Retirement Plan, (the “Plan”), effective July 1, 2024, in coordination with the Towns of Warren and Morris who have also agreed to assume a co-sponsorship of the Plan. Sponsorship of the Plan shall cover only former employees and retirees of Regional School District No. 6, in compliance with § 7-450 of the General Statutes.

(B) Sponsorship and administration of the Plan pursuant to the terms of this section shall be governed by an interlocal agreement, adopted herewith, and as from time-to-time may be amended, pursuant to §§ 7-339a through 7-339l of the General Statutes.

(C) The Town of Goshen shall appoint one member to the Intermunicipal Board of Trustees for the Former Regional School District No. 6 Pension Plan. Such Intermunicipal Board shall have a total of three members, one from each of the three former Regional School District No. 6 towns. The Town of Goshen member of the Intermunicipal Board shall be appointed by unanimous vote of the Board of Selectmen for a three-year term. No beneficiary under the Plan may serve as a representative on said Intermunicipal Board. In the event of a vacancy of the Goshen seat on the Intermunicipal Board, the Board of Selectmen shall unanimously appoint a replacement Goshen member to serve out the balance of the unexpired term.

Section 3. Effective Date

This ordinance shall take effect fifteen (15) days after publication of a summary of its provisions in accordance with Connecticut General Statutes § 7-157(b).
