### a. 2023-2024 Finance Report

There were two resignations, an English teacher and a Guidance Counselor. The district did not need to backfill these positions heading into Region 20, so there is savings. The district continues to monitor long-term absences, as there will be a need for long-term subs for the second half of this year.
