Chairman Bunnell called for any further nominations, and hearing none, called for a motion to close nominations.

<u>Motion:</u> Sky Post moved to close nominations to fill the alternate member vacancy. Ed Gadomski seconded the motion. All vote aye and the motion carried.

Chairman Bunnell called for a vote approving the nomination of Richard Furniss to the BOF as an alternate member and all voted aye. Chairman Bunnell will send a letter to the Town Clerk concerning the two new BOF members.
