- 4. Declaratory Ruling SR Litchfield LLC
 - Applicant will not be present because they do not need because they are skipping local and going directly to the State for approval. Cox brought up some background for this type of application and the CT Siting Council.
 - Concerns to be forwarded to the Siting Council.
 - i. Extensive drainage is being proposed. The Commission is concerned about water protection and wetlands protection.
 - ii. No contours were proposed on the maps provided to the Commission. Is the site going to be stable?
 - iii. This is a scenic site. Will there be a protection of the views for this gateway or the adjacent properties?
 - iv. With the loss of around 2000 trees, will the groundwater be protected or is there a detention area to protect the river.
 - v. Will the fence being proposed be enough to protect the site?
 - vi. How will the site be cared for during operation?
 - vii. The Commission is very concerned about the amount of disturbance rather than the siting of the solar field. A great deal of soil is to be moved to install the site.
 - viii. The Commission is concerned about the disposition or remediation of the site at the end of the useful life.
 - ix. The Commission is concerned about the damage to the surrounding lands during installation.
 - Motion by Cox and seconded by Stoner, that the Commission send a letter stating our concerns. Unanimous.
- 5. Open Space Acquisition Project
 - No new information.
