# 1. Benzoni (Canadaigua) – 481 Bantam Road

Add 8 parking spaces

Cynthia Rabinowitz, Northwest Conservation District, sent an email dated 8/29/19 after her visit to the property. She suggested they plant trees or bushes in rain gardens or swales to minimize runoff. William Todd Clark and Derrick Clark of Clark Land Surveying said they agreed and showed their plan. The wetlands behind the area were flagged by Tom Stansfield. They proposed treating the stormwater with infiltrators far away from the wetlands that will catch salt from the road. They also plan to do heavy maintenance every year to control the invasives in the rain garden and swales. They will plant evergreens and shrubs on the side near the road but not in the State right of way. J. Healy asked for inclusion of a condition that they will replace the trees if they die. D. Tobin suggested a minor bond to maintain the invasives, but A. Paradise suggested a meeting to determine how they would do this in any application.

**Motion:** J. Healy moved to approve the application of Canadaigua LLC, as shown on Site Plan Modification Additional Parking Plan, revision dated 9/10/19, prepared by Clark Surveying LLC, with the request that it be installed as shown with trees and with provision to replace trees if they die. Further they must have Dennis Tobin inspect the site during infiltrator construction with photo documentation and the Stansfield plan, and include Mr. Stansfield's report as part of the record.

#### 4. Vallecilla – 12 Old Forge Hollow Road

Two lot re-subdivision

Jason Dismukes, agent for Mr. Vallecilla, was present to explain the plan to cut off a 2-acre corner building lot for a proposed house and pool from the 7.3 acre property. The wetlands were delineated by Mike Temple of Nutmeg Soil Services. The Shepaug Tunnel aquaduct crosses the property with a right of way, but is on the original parcel so they won't need to do easement and deed work for both parcels. He has Torrington Area Health District's approval and is dealing with the City of Waterbury on the Shepaug aquaduct issue. There is a man-made pond and Town drainage swale along Old Mount Tom Road, but is not part of the new lot. A. Paradise asked for all technical detail summarized in a narrative with bullets tying it to the map, or by adding an extra sheet to the drawing.
