#### 1. Merli (Final Move LLC) - 16 Thomaston Road

Construct 6 ft. security fence (40'x70') with 20 ft. rolling gate

Mr. Blazek read a letter dated 7/10/19 from the applicant withdrawing the application.

#### 2. Hardscrabble - 569 Bantam Road

7/10/19

Building addition (5,328 sf), roof drainage and construction/emergency access road

Jack Baker of Hardscrabble and Ken Hrica, PE and Licensed Land Surveyor for Hardscrabble, were present to review the project. Mr. Baker is planning a storage addition on the right side of the building. The soils are man-made as they were previously disturbed, and a wetland has been created over time. The wetlands line has been highlighted, and is also the brush line. There will be a rain garden off the back of the building into an upland review area to catch the roof runoff and will filter through a stone wall and filter to a riprap area in the uplands. It will continue to a culvert below the old railroad tracks. The emergency access road is right in front of the building. The addition will be slab on grade with a frost wall foundation. They will pave the parking lot and driveway per Litchfield Zoning Regulations. The entire area is regulated.

There is a lot of ledge, so they sited the house on a plateau. They are disturbing .3 acre of the buffer. Septic system is located within the buffer with an application pending on the design with Torrington Area Health District.
