1. Warner – 58 Byrnes Avenue

2/8/17

Pond maintenance 2/3 acre with 1/3 acre removal of invasive species and 1/3 acre removal of sediment at pond inlet

Mr. Warner brought a map showing the pond area. From the edge of the pond to his property line he would like to clear out the invasives and do some dredging to remove sedimentation. The pond is about 8 ft. in the deepest part. He will use an excavator after dropping the water level 2 ft. There is an earth dam at the end. He will need a couple loads of fill. Mr. Blazek said they don't usually fill wetlands, but Dr. Tobin thought it would be good for the dam area. He will leave all the trees and possibly plant more after. He will dry out the spoils near the barn.

Motion: Barbara Brower moved to approve the application of Robert Warner at 58 Byrnes Avenue for pond maintenance on 2/3 acre with 1/3 acre removal of invasive species and 1/3 acre removal of sediment at the pond inlet as per discussion.

2. Gromet – 70 Newton Road (Parcel B)

Construct septic in upland review area

Dennis McMorrow, Berkshire Engineering and Surveying, showed a vicinity map locating the new lot after the fourth house south of Fenn Road on Newton Road. There is a brook, and the wetlands have been flagged by G. Malia. The Gromets are going to build a new home and plan to sell their other one. The house, driveway and proposed well are outside of the regulated area. The closest area of disturbance is 69 ft. from the brook. They have an erosion and sedimentation control plan with original stone wall acting as additional silt protection. Mr. McMorrow said this application is fairly straight forward with a gently sloping lot.

Motion: J. Hamell moved to approve the application of Gromet, 70 Newton Road, Parcel B, for construction of a septic system in the upland review area.

It would include a performance allocation of \$155,000 and a maintenance allocation of \$120,000. Mark Greenberg said he needs to free up cash due to cost overruns and this would help him. The Town would hold the surety bond. Dr. Tobin said he will need an application review fee of \$500 for Attorney Steve Byrne, the bond from Mr. Greenberg, and then the Commission can move on this at the next meeting.
