## APPLICATION RECEPTIONS

1. Stop & Shop Bond Modification and Release - IW Permit #CC00001073: Attorney Chris Dupont was present to represent Mr. Greenberg in asking for the release of the performance bond in the amount of \$170,000. Chairman Blazek read the letter from Byrne & Byrne dated 7/21/17 suggesting the Commission can release the performance bond. He also read a letter dated 6/8/15 from Byrne & Byrne also advising on release of bonds per CT General Statutes. Dr. Tobin said this performance bond to be released totals \$155,000 per Finance Dept. memo dated 811/17. The difference of \$15,000 was spent on work done by Northwest Conservation District. There also remains a maintenance bond in the original amount of \$120,000 to be held and reduced as appropriate.

Motion: Anthony Paradise moved to approve the change of the \$170,000 request to \$155,000 because of the \$15,000 expenditure to NWCC for soil erosion and sediment control inspection. This will release the \$155,000 cash performance bond to Mark Greenberg.

Placement of pre-fab 3-stall equine shed row barn on stone process pad (4" deep) and removal of invasive Japanese bamboo along wetlands area

Jenna Nicol showed photos and said the shed with size of 30' X 12' would not be used to house horses, but it will be built according to the equine management plan. She has to board her horses elsewhere because she only has 1.74 acres. She would like to remove Japanese knotwood plants as well. Dr. Tobin described an interesting non-vernal pool where runoff collects, about 142 ft. from the structure.
