a. Heritage Plan/Green Conservatory Committee - Excavation Update

a. Budget

There was a discussion about the renovation of the Ambulance Building to house the Borough of Litchfield offices in conjunction with affordable housing. W. Boehme shared that he did not think using tax payers money for the renovation is appropriate. D. Patterson suggested figuring out what was needed for the project and the shared cost after Grant application.

b. Sidewalks

There was a discussion of 3 change orders from Cardinal. There was a discussion over the supervision of this project. The BOL Board decided to have W. Buckley and W. Boehme supervise the project. W. Buckley moved a Motion and D. Patterson second, to approve the 3 Change Orders, one dated 7/15/2025 and two dated 8/15/2025, not to exceed the total of \$17,500 and to authorize cardinal to do the work outlined subject to be expanded to include to finalize the plans to the level of construction and bid documents to satisfy HDC and DOT approvals. All in favor, Motion approved.
