## Litchfield SMART Task Force Meeting Minutes

February 10, 2021

Chairman J Geci called the meeting to order at 4:05 pm.

Minutes from January 13, 2021 – correction: the Sustainable Litchfield Liaison is John Post., not James Keithan. Corrected minutes accepted unanimously.

## **RECYCLING SHED UPDATE**

N Boccio shared the statistics on the tonnage of materials collected and recycled for the first 6 months. There was a 37% increase in revenue, covering all expenses on the materials that have a cost to dispose.

## **EPOC ENVIRONMENTAL APPLICATION FOR GRANT**

N Boccio filled out an application for grant for \$23,000 to fund toters at school and municipal lots. N Boccio has put in a request for a sandwich board to give information at the Recycling Center.

Members discussed the possibility of organizations in the community collecting composting, including at the Tapping Reeve Meadow. K Zullo will be organizing a home composting workshop with Lynn Fulkerson for the spring.

C Liley reported on a meeting with A Devaux and Dean Birdsall on the possibility of composting at the high school. C Liley noted the need to have composting on site. L Losee suggested the need for a student club to handing composting, but a teacher is needed for continuity. Wamogo does compost. C Liley and K Zullo will reach out to see how their compost program is run.

## **PUBLICIZING, EDUCATING, LEGISLATING POSSIBILITIES**

The Litchfield.bz article on composting was well received. K Zullo proposed a weekly social media post to convey information about Litchfield's SMART team initiatives and general recycling and composting news.

D Raap will look into the Aquarian Rain Barrel program. D Wilson suggested using barrels that he has at the Sewer Treatment plant for the rain barrel program.

L Losee raised the question of how to adjust the program if things are locked down.
