


The following items will be considered:


- I. To adopt the resolution and authorize the First Selectman to sign the Commercial Property Assessed Clean Energy (C-PACE) Agreement
- II. To approve the 2019/20 Annual Financial Report
- III. To appropriate a sum of \$110,000.00 to Account 01-4201-43151( LVA COVID-19 Loan), the source of funds for such appropriation to be by way of transfer from Account 01-8101-56102 (Medical), as recommended by the Board of Finance in Budget Transfer #1
- IV. To appropriate a sum of \$67,670.38 to Account 56-9501-47001 (Capital Non-Recurring), the source of funds for such appropriation to be by way of transfer from various closed capital projects, as recommended by the Board of Finance in Budget Transfer #2
- V. To update Code of Ordinances for Fire Marshal fee schedule
- VI. To update Code of Ordinances for Building Department fees
