OCTOBER 13, 2021 TOWN OF LITCHFIELD

A Special Town Meeting of the Town of Litchfield was held on Wednesday, October 13, 2021 at the Litchfield Intermediate School Auditorium. There were approximately 90 people in attendance, including Michael D. Rybak, Town Attorney. In the absence of the First Selectman, Selectman Jeffrey Zullo called the meeting to order at 7:02 p.m. Lisa A. Losee, Town Clerk, served as Clerk.

Motion was made by Michael D. Rybak, Jr. and seconded by Margaret Hunt that Cleve Fuessenich preside as Moderator. Jonathan Torrant moved to close nominations, seconded by M. Hunt. It was then moved, seconded and voted unanimously that C. Fuessenich serve as Moderator. Motion carried.

The Moderator read the Certificate of Posting, which is attached to these minutes as Exhibit A.

J. Torrant motioned to waive the reading of the Call of the meeting, seconded by Peter Losee. A copy of the Warning was made available to all in attendance and is attached to these minutes as Exhibit B. All voted in favor and the motion carried unanimously.

The Moderator read Item I. To consider and act upon various line item transfers to adjust General Fund departmental budgets to be within approved spending limits for fiscal year 2020/21 in the total amount of \$196,127.00, as recommended by the Board of Finance in Budget Transfer #6.

A copy of the transfer was made available to those present and is attached to these minutes as Exhibit C. J. Torrant made motion to approve the transfer as presented, seconded by P. Losee. Vote by hand count was 61 in favor and none opposed. Motion carried unanimously.

The Moderator read Item II. Shall the Town of Litchfield join in the establishment of a temporary regional school district study committee with Regional School District No 6, pursuant to Connecticut General Statutes Sec. 10-39.

John Morosani motioned to approve Item II, seconded by J. Torrant. Peter Litwin commented that he's waited 60 years for this vote; John Morris asked for explanation of process and statutory timeframe to complete study. J. Zullo explained the need to approve this formal committee per statute, 5 members including 2 from the Board of Education will be appointed to represent Litchfield and work with 5 members chosen to represent Region 6 along with 1 representative from the State Department of Education. They will continue work where the preliminary study group left off and prepare a plan with the hopes of bringing it to referendum in June 2022. Atty. Rybak stated that the study could take up to two years but did not think it would take that long. The Plan developed by this group will need to be filed in the Town Clerk's office of each town-

the same Plan-Town Clerks will publish legal notice that the Plan will be available for public inspection for 30 days. A referendum will need to be held simultaneously in the towns of Litchfield, Morris, Goshen and Warren; on the same day, at the same time, with the same question on the ballots; and it must pass by majority vote in every town. J. Torrant has waited for vote 58 years and cannot imagine how this could be voted down. Jennifer Zorne spoke against the regionalization speaking to past experience with Region 6, unequal payoff of debt, feeling that Litchfield will be subsidizing Region 6, that other towns will not support tax increases to support schools and feels it will fall on Litchfield to do so. J. Zullo agreed financial equalization a valid issue and would entertain that the BOS, BOF and BOE form an adhoc committee to support this study group; that debt, assets, and revenue must be equal and Litchfield be well represented. Burke Gibney would like a proper study done but was not in favor of the first Plan of the preliminary study group endorsed by the BOE; does not believe the cost savings would be as predicted; preliminary Plan shows Litchfield seeing a 1.6% decrease in taxes while Warren, Morris and Goshen would see an 11% decrease in taxes; other towns to save more; Litchfield not well represented; deal breaker would be the governmental structure of the regional board that would consist of 3 representatives of each town meaning that Litchfield would only have 3 votes on any decision to 9 votes from Region 6 towns and 8 votes are needed to approve anything; other towns would have complete BOE control while majority of funding will come from Litchfield; will only support a fresh start with no members who were on the preliminary group involved. Jodiann Tenney supports work done by initial group agreeing that new people would be needed for a fresh look as well as those with historical knowledge; must have faith that BOE members will put students above the town. J. Zullo confirmed there would be agendas, minutes, meetings are public, public comments and public hearings will allow for public participation in this process. J. Torrant understands concerns but we must go forward and vote yes tonight to establish this study group. J. Zorne looking for more transparency, has the feeling that this is being pushed through due to steps the administration has already taken such as combining the schools' websites and moving all administration to Wamogo; there is the appearance that this is a done deal. J. Zullo supported the need for clear study stating that Litchfield has more debt as well as more revenue in the solar panels and what happens to that revenue needs to be studied. Helen Bunnell asked who was on the preliminary study group and there was no one in the crowd who could answer her.

H. Bunnell moved the question, seconded by Adrian Selby. It was so voted unanimously by voice to do so. The vote was then taken by hand count. 80 people were in favor and none were opposed. Item II was unanimously approved.

The Moderator read Item III. To appoint five members of the temporary regional school district study committee, two of whom must be members of the Litchfield Board of Education, pursuant to Connecticut General Statutes Sec. 10-40.

The Moderator called for nominations from the Board of Education. Matt Terzian, Chairman of the BOE, nominated John Morosani and Lynne Stone, seconded by Frank Simone. Nominations were closed and motion made and seconded to do so and move the question. J. Tenney motioned to appoint J. Morosani and L. Stone to represent the BOE, seconded by B. Gibney. Vote by hand count was unanimous and motion carried.

The Moderator stated that the vote for the remaining 3 members would be done by paper ballot and ballots would be counted by the Registrars of Voters. He then called for nominations for the appointment of three members At Large.

J. Zullo nominated the following who had expressed interest to the office of the First Selectman in serving on this regional committee. Those he nominated were: Jill Johnson, Kathleen Tranquillo, Frank Simone, Rene MacKenzie, Erin McKenna, Bill Davenport, and Caroline Wilcox Ugurlu. J. Torrant seconded the nominations. P. Losee nominated Julie Hrica, seconded by M. Hunt. J. Torrant motioned to close the nominations, seconded by P. Losee, which passed unanimously by voice. Each nominee present was given the opportunity to speak on their behalf. Vote was then done by paper ballot. Results are as follows:

Fiscal Year 2020/2021 Budget Transfer #6 for \$196,127

The Finance Department is requesting the following year-end transfer to adjust General Fund departmental budgets, including salaries, to be within approved spending limits. The total of \$196,127,00 is .006 of the original budget of \$31,888,577.
