The electors and citizens qualified to vote in Town Meetings of the Town of North Canaan, County of Litchfield and State of Connecticut are hereby notified and warned that a Town Meeting of said Town of North Canaan will be held in the Town Hall, 100 Pease Street, at 7:00 P.M. on Monday May 18, 2026, for the following purpose:

- 1). To consider and take action on the proposed municipal portion of the budget as recommended by the Board of Finance.
- 2). To consider and take action on the proposed North Canaan Elementary Education portion of the budget as recommended by the Board of Finance as reduced by the supplemental education payment by the State of Connecticut pursuant to Legislative enactment LCO #6252 such that the amount of the Board of Education request shall be made whole by such supplemental State funding.

NOTE: Both portions of the budget listed above must pass in order for the budget to be adopted.

- 3). Per Appendix 1: To adopt an ordinance pursuant to which the Town will become a member town of the Northwest Regional Recovery Authority.
- 4). Per Appendix 2: Shall the Town of North Canaan accept from the State of Connecticut the following 27.45 acre parcel of land, pay the State \$1,000 in payment of administrative, and transfer expenses?
- 5). Per Appendix 2: Shall the Town of North Canaan accept from the State of Connecticut the following 9.45 acre parcel of land, pay the State \$1,000 in payment of administrative, and transfer expenses?
- 6). To consider any other business proper to come before the town meeting.

Appendix 1

**ORDINANCE DESIGNATING
NORTHWEST REGIONAL RECOVERY AUTHORITY
AS THE TOWN'S RESOURCE RECOVERY AUTHORITY**

1. Pursuant to the provisions of Chapter 103b, Sections 7-273aa through and including 7-273oo, of the Connecticut General Statutes, the Town of North Canaan (the "Town") designates Northwest Resource Recovery Authority ("NRRRA"), recently established by the City of Torrington, a political subdivision of the State of Connecticut created for the performance of an essential public and governmental function, as the Town's regional resource recovery authority.
2. The Town shall be a member municipality of NRRRA entitled to the rights set forth in NRRRA's Bylaws, including one (1) vote on NRRRA's Board of Representatives.
3. The Town's Board of Selectmen shall appoint one representative and one alternate representative to NRRRA's Board of Representatives, the initial term to be either one, two, or three years as determined by the then-sitting representatives of NRRRA. Any vacancy in the office of the Town's representative or alternate representative shall be filled by the Board of Selectmen.
4. This ordinance will become effective fifteen (15) days after publication of notice of adoption in a newspaper having circulation in the Town.

Appendix 2

Acquisition of Two Parcels of Land

1. Shall the Town of North Canaan accept from the State of Connecticut the following 27.45 acre parcel of land, pay the State \$1,000 in payment of administrative, and transfer expenses?

A FIRST PARCEL OF LAND, known as the "Camp Brook parcel," being 27.45 acres of unimproved land owned by the Connecticut Department of Transportation which is comprised of four separate tax parcels located in North Canaan easterly of Ashley Falls Road and North Elm Street listed and depicted as follows: North Canaan Tax Assessor's Map 22, Lot 333-0; TA Map 29, Lot 041-0; TA Map 29, Lot 048-0; and TA Map 29, Lot 049-0, to be maintained as open space in perpetuity and used for low-impact, and non-motorized public recreation and to maintain its recreational, educational and natural benefits.

2. Shall the Town of North Canaan accept from the State of Connecticut the following 9.45 acre parcel of land, pay the State \$1,000 in payment of administrative, and transfer expenses?

A SECOND PARCEL OF LAND, known as the "South Greenway parcel," being an approximately 9.45 acres of unimproved land owned by the Connecticut Department of Transportation located in North Canaan between East Main Street (CT Route 44) and North Elm Street fronting only on North Elm Street listed and depicted on the North Canaan Tax Assessor's Map 22, Lot 318.
