**\*Rules of Procedure Article IV Officers (B)**

Current language:

B. The terms of office shall be for **one year**, or until a successor **is chosen and qualified**.

C. Officers may succeed themselves for a maximum of **three consecutive terms**, following which they must **wait at least one year** before being re-elected to that office. Officer titles will change from chairman and vice-chairman to Chair and Vice-chair, and references to he/his/him" will be changed to they/their/them."

Proposed change:

B)The terms of office shall be for **two years**, or until a successor **is elected for the remaining term**.

c) Officers may succeed themselves for a maximum of **two consecutive terms**, following which, they must **wait at least two years** before being re-elected to that Office. Officer titles will change from chairman and vice-chairman to Chair and Vice-chair, and references to he/his/him" will be changed to they/their/them."
